METROPOLITAN GOVERNMENT OF NASHVILLE
AND
DAVIDSON COUNTY, TENNESSEE
AUGUST 2, 2007

NOTICE IS HEREBY GIVEN that a General Election for the Metropolitan Government of Nashville and Davidson County, Tennessee will be held in all Davidson County voting locations on **Thursday, August 2, 2007**. Offices to be filled are as follows: Mayor, Vice-Mayor, Five (5) Council Members at Large, and one (1) District Council Member for each thirty-five (35) Council Districts. The term of each office is four (4) years. Also to be filled is the position of Metropolitan Board of Public Education Member for School District 3. The term will be for the balance of the unexpired four (4) year term.

QUALIFYING DEADLINE for each of the above offices is **12 Noon on Thursday, May 17, 2007**. Persons who desire to become candidates must complete and file a legally sufficient nominating petition with the Davidson County Election Commission. The petitions are issued by the Commission and are available at the Commission Office.

WITHDRAWAL DEADLINE for candidates for each of these offices to remove their names from the ballot is **12 Noon on Thursday, May 24, 2007**. A Notice of Withdrawal must be in writing and signed by the candidate.

THE LAST DAY TO REGISTER IN PERSON to vote in this election is **Tuesday, July 3, 2007, by 4:30 p.m.** **THE ELECTION COMMISSION OFFICE WILL BE CLOSED WEDNESDAY, JULY 4, 2007, IN OBSERVANCE OF THE FOURTH OF JULY HOLIDAY.** The last day for a name change, or to make any other alteration to the registration record is **Saturday, July 28, 2007**. Applicants may register to vote at the Davidson County Election Commission Office or by using a Registration by Mail form available at any Post Office, Public Library or Department of Safety and Vehicle Registration location. Registration by Mail forms **MUST** be postmarked (hand cancelled by the U.S. Postal Service) no later than **Tuesday, July 3, 2007**. Registration by Mail forms may also be hand delivered to the Davidson County Election Commission, but must be received no later than **4:30 p.m. Tuesday, July 3, 2007**. **ANYONE WHO REGISTERS BY MAIL MUST, BY LAW, VOTE THE FIRST TIME IN PERSON WHETHER ON ELECTION DAY OR DURING EARLY VOTING.**

ALL REGISTERED VOTERS OF DAVIDSON COUNTY WHO HAVE MOVED WITHIN THE COUNTY OR HAD A NAME CHANGE ARE ENCOURAGED TO MAKE THESE CHANGES BY NOTIFYING THE DAVIDSON COUNTY ELECTION COMMISSION AS SOON AS POSSIBLE. VOTERS WHO FAIL TO DO SO PRIOR TO ELECTION DAY WILL EXPERIENCE A DELAY IN VOTING.

THE DAVIDSON COUNTY ELECTION COMMISSION OFFICE is located at the Metro Office Building, 800 2nd Avenue South, First Floor, Nashville, Tennessee. The office is open from 8:00 a.m. to 4:30 p.m. weekdays and will be open for registration on the following Saturdays:

JUNE 30, 2007 FROM 9:00 A.M. TO 4:00 P.M.
